- 2. 3. Council activities over last year

- a. 319 grant (Geri):
 - Electronic fact sheet for the 319 Watershed Restoration Grant has been developed, and there is a link to it at the PdN webpage.
 - Data Survey Consultant contract will be awarded to Dr. Phil King who
 will utilize several graduate students to create the WRAS. A separate
 contract for a wildlife biologist to join that team is also being discussed by
 the subcommittee.
 - Stakeholder meetings are planned for Doña Ana County and City of Las Cruces to learn about County Planning and Development and how it will affect the river. A field trip around the watershed is planned for stakeholders next year. Also, a GIS Workshop to introduce stakeholders to the uses of GIS will be offered.
 - Contribution Forms- Geri reminds the Council that if they have made any contributions to 319 to please fill out your forms. Contract Geri if you do not have an electronic copy.
 - Source tracking study recommended by George Di Giovanni of TAES.
 - URGWOM is in the process of developing a five year plan in 2007-2008 that will include stakeholders and improve the operation model to track water quality.

b. Coordinated database: Zhuping updates

Title: Development of a Coordinated Database for Water Resources and Flow Model in the Paso del Norte Watershed.

Phase I: Enhancement of the Coordinated Water Resources Database for the Paso del Norte Watershed

Phase II: Development of RiverWare model for the Rio Grande flow in the

Rincon Valley for flood control planning

Phase III: Development of RiverWare model for the Rio Grande flow in the Mesilla Basin for flood control planning.

Phase IV: Development of RiverWare Conceptual model for the Rio Grande flow in the Mesilla Basin and the Rio Grande reach below El Paso for flood control planning.

Enhancement of GIS coverage and data transfer protocol was included for each phase.

- Governor Richardson has announced 2007 as Year of Water in NM pledging \$7.5 million for river restoration. There are lots of restoration projects being put on the table that are ongoing. Kevin suggests a \$300,000 watershed restoration project for our stretch of the river. Kevin offers to draft a Council position paper on river restoration w biosubcommittee that could be used for future funding proposals.
- Steve Smullen updated the Council on the first stakeholder meeting for the Canalization EIS at EBID on December 12, 2006. The meeting introduced a hydrology and hydraulics study about the restoration project. Inventory and suggested sites for restoration will be done at next meeting in May.
