- 3. Announcements:
  - a. **Woody Irving** Water Conservation Field Services Coordinator's Meeting, pertains to watersheds; Regional coordinators will be present on November 7 in El Paso? He will forward information to Conrad/Sue. Would like to have at least two representatives from PdNWC present to be in the stakeholder's portion of the meeting. Interest in applying for grants. FOA-Grant structures, criteria for ranking the grants. Still putting agenda together.
  - b. Kevin Bixby SWEC- Proposed transfer of the Mesilla Valley State Park to the New Mexico Game & Fish Dept. State Park says it has no money to manage the park but Game & Fish has lots of money and staff because they get funding through licenses. Recent 2-hour open house. A lot of opposition to the transfer including SWEC. The agencies did not consult with the community enough about the transfer. New 1-month public comment period started October 10<sup>th</sup>. Can submit comments on the agencies websites. Game & Fish already hired a contractor to put together a management plan. SWEC is having its annual fundraiser 20<sup>th</sup> Gala Saturday and he has tickets. It's at the downtown plaza.
  - c. **Peter CLC** Watershed books and stormwater citizen brochures are available to those interested. Great for public outreach and education.
  - d. **Delbert Humbertson**, USGS- Last few months the USGS has published an investigative report about Mesilla Basin characterized geophysical analysis, 200-page report. Will provide report through email.
  - e. Ari's memorial services- January 2018, no exact date was set.

- a. PdNWC Financial Report –**Zhuping** gave handout. Expenditures and one more invoice expected on the USBR funds.
- b. Technical Committee Report nothing new to report.
- c. Environmental Committee **Leslie Grijalva** (Environmental Committee)-Brian, Gill and Leslie received the fish study documents from Kevin. Chris asked them to review the study to see if it's in line with the MOU. Deadline to submit comments back to him is October 27<sup>th</sup>. After it has been reviewed and it's consistent with the MOU he can approve invoice and pay for the study. Liz asked to look at the study as well too. The fish study/report will be on SWEC's website. Chris is reviewing and comments are welcome.

d. Website update— **Chris Brown**- (Website) Handouts provided. Developed an outline for goals of website. Created blended English/Spanish website instead of 2 separate, 1 English and 1 Spanish. Linked docs were not translated. Hugo Rojas developed site and Liz was on the Advisory Committee. Website was strictly designed using NMSU web standard guidelines. Hugo and Sarah overhauled website making it bilingual. Coordinated dabatase website now runs on ArcGIS Online. A new link will be available in summary minutes. Chris and Hugo provided a presentation which will be available online. He invites any input that anyone may have. There are a list of broken links that they want help fixing. Comments due 10/27.

- a. EBID- Samantha Barncastle discussed the status of ongoing water litigation. Supreme Court Special Master filed Feb 2017. Oral arguments in 2018. Lower Rio Grande water users have come together to discuss resolutions and maybe this is the path to eventual settlement negotiations.
- b. EBID- Dr. Phil King presented on Depletion Reduction and Offset Program, which is a controlled fallowing program paid by municipal/industrial users.
- c. SWEC- Kevin Bixby discussed the fish study, which recommends four locations for possible aquatic habitat (Broad Canyon, Las Cruces effluent, La Mancha, and Mesilla Valley Bosque).
